Nathan Atkinson, Stephen Joseph Wright, Gary Krenz, Sarah J. Hamilton, Jean-Luc Thiffeault, Somesh Jha, Joanne Kane, and Leah Dudley (collectively, “Proposed Intervenors”), through their counsel, hereby move to intervene in the above-captioned case pursuant to this Court’s Order of October 6, 2023, and Wis. Stat. § 803.09.

Proposed Intervenor Atkinson has not been involved in any redistricting litigation before this Court. Proposed Intervenors Wright, Krenz, Hamilton, Theriault, and Jha were petitioner-intervenors in the *Johnson* redistricting litigation in 2021–2022 and were known then as the “Citizen Mathematicians and Scientists.” On August 4, 2023, Proposed Intervenors Wright, Krenz, Hamilton, Theriault, and Jha filed the *Wright* Petition to Commence an Original Action, which was denied by the Court on October 6, 2023. Proposed Intervenors Kane and Dudley were not parties to the *Johnson* litigation, but they joined the *Wright* Petition in August 2023.

Proposed Intervenors’ grounds for intervention are set forth in a supporting Memorandum, as required by the Court’s Order of October 6. Although the Court’s Order does not expressly so require, consistent with Wis. Stat. 803.09(3), Proposed Intervenors also attach a Petition in Intervention that adopts all the allegations and prayer for relief with

respect to the two claims in the *Clarke* Petition to the Supreme Court of Wisconsin to Take Jurisdiction of an Original Action that remain operative.
