Petitioners Rebecca Clarke, Ruben Anthony, Terry Dawson, Dana Glasstein, Ann Groves-Lloyd, Carl Hujet, Jerry Iverson, Tia Johnson, Angie Kirst, Selika Lawton, Fabian Maldonado, Annemarie McClellan, James Mcnett, Brittany Muriello, Ela Joosten (Pari) Schils, Nathaniel Slack, Mary Smith-Johnson, Denise (Dee) Sweet, and Gabrielle Young, Intervenor-Petitioner Governor Tony Evers, Respondents Senator Tim Carpenter, Senator Chris Larson, Senator Mark Spreitzer, Senator Dianne H. Hesselbein, and Senator Jeff Smith, and Intervenors-Petitioners Nathan Atkinson, Stephen Joseph Wright, Gary Krenz, Sarah J. Hamilton, Jean-Luc Thiffeault, Somesh Jha, Joanne Kane, and Leah Dudley (collectively, “Movants”), through their respective counsel, respectfully move for an Order directing Intervenor-Respondent the Wisconsin Legislature to instruct its Legislative Technology Services Bureau (“LTSB”) to review and correct the statewide ward “shapefile” that the Legislature, this Court, and all parties to *Johnson v. Wisconsin Elections Commission* (Case No. 2021AP1450-OA) used in 2021 and 2022 for purposes of state-legislative redistricting (the “LTSB Redistricting Dataset”) so that the shapefile accurately delineates wards and municipalities, and to re-release the corrected shapefile no later than December 1, 2023.

If the Court decides that the existing state-legislative maps violate the Wisconsin Constitution, it is critically important that the Court and the parties *all* can rely on a *common* redistricting dataset that accurately describes Wisconsin's county, town, and ward lines as of the most recent Census Day, April 1, 2020. *See* Wis. Const. art. IV, §§ 3, 4. If the parties use different shapefiles, it will be nearly impossible for the Court to compare the parties' remedial proposals against one another. And even if the parties use the same shapefile, if that shapefile contains data errors incorrectly delineating wards and municipalities, the Court will be unable to ensure that the parties' remedial proposals fully cure any constitutional violation the Court finds.

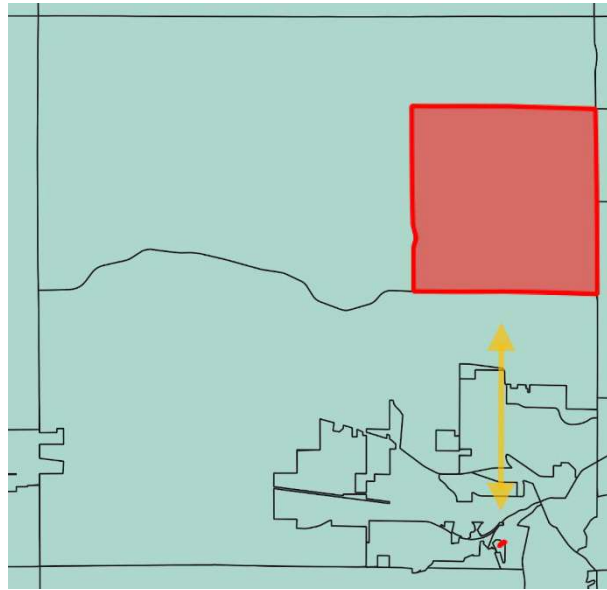
The LTSB Redistricting Dataset shows 72 counties, 1,850 municipalities (cities, villages, and towns), 7,136 wards, and 202,510 Census blocks. A proper redistricting dataset places each Census block into one ward, one municipality, and one county, both to facilitate precisely delineating districts and to ensure accurate population totals—because Census population data are available for each Census block but not for any geographic area smaller than a Census block. Accurately delineating all wards, municipalities, and counties is an essential step in drawing and evaluating lawful Wisconsin state-legislative districts.

This Motion is necessary because it appears that the LTSB Redistricting Dataset that this Court and all parties relied on in *Johnson* contains errors and thus does not accurately delineate all wards and municipalities. Attached to this Motion as Appendix A is an illustrative (but likely not exhaustive) list of more than 200 ward fragments—that is, single Census blocks or small groups of Census blocks—for which the LTSB Redistricting Dataset seems to misidentify the municipality name or the ward number or perhaps both.<sup>1</sup>

For example, take Ward 3 in the Town of Sheboygan Falls in Sheboygan County. This ward encompasses a compact area in the northeast part of the Town (see the large red area in the map below). According to the LTSB Redistricting Dataset, however, the same ward also contains a single Census block (Census Block # 551170106013008, which is also red in the map below) that is located about three miles south of the rest of the ward and is sandwiched between Ward 1 of the Town of Sheboygan Falls and Ward 3 of the City of Sheboygan Falls (also in Sheboygan County). Presumably, the LTSB Redistricting Dataset should have labeled this stray Census block as belonging to either the Town's Ward 1 or the City's Ward 3—not to the Town's Ward 3.

Although it appears clear that the LTSB Redistricting Dataset's assignment of this Census block is in error, it is not obvious, at least from the face of the Dataset, whether the error is the name of the municipality (Town, rather than City, of Sheboygan Falls), the number of the Ward (Ward 3, rather than Ward 1), or perhaps both. So, as to this Census block and the wards and municipalities that it implicates, the LTSB Redistricting Dataset appears to be not only inaccurate, but inaccurate in a way that could frustrate efforts to draw and evaluate constitutional legislative districts in this part of Sheboygan County.

Unfortunately, this is not an isolated example. As the list in Appendix A indicates, the LTSB Redistricting Dataset contains at least 204 ward fragments that, like the Sheboygan County Census block described above,

need to be reviewed and probably corrected. And LTSB may find other errors that need correction, as well.

Because it is critical that all parties—and the Court—be able to rely on a common, accurate ward shapefile in any remedial phase of this litigation, Movants ask that this Court order the Legislature to instruct the LTSB to immediately review, correct, and re-release by December 1, 2023, a statewide ward shapefile that accurately delineates all wards and municipalities.<sup>2</sup>

WHEREFORE, Movants pray for the relief as set forth herein.
