As one of the attorneys for the Clarke Petitioners in this case, I write in response to your December 26, 2023 memorandum to the Court regarding technical specifications and data requirements. Specifically, Petitioners wish to outline where you can find the evaluations of their remedial maps ("Clarke maps") across the criteria the Court identified in its opinion and you included in your memorandum.

The evaluations of the Clarke maps on criteria numbered 1, 2, 3, 4, and 7 in your memorandum can be found in Prof. Christopher Warshaw's expert report, which is included in the Petitioners' January 12, 2024 appendix at pages App. 007-047. Additional information on criteria 2, 4, and 7 can be found in the declaration of Prof. Ronald Keith Gaddie, which is included in the Petitioner's appendix at pages App. 123-126.

The evaluation of the Clarke maps on criterion 5 can be found in the text of Petitioners' January 12, 2024 brief in support of remedial maps at pages 23-25.

The evaluation of the Clarke maps on criterion 6 can be found in Prof. Aaron Weinschenk's expert report, which is included in Petitioners' appendix at pages App. 057-115.
