COURT'S REMEDIAL SCHEDULING ORDER**

On January 11, 2024, this Court denied a motion for reconsideration of its December 22, 2023 post-decision scheduling order filed by (1) respondents, Senators Cabral-Guevara, Hutton, Jacque, Jagler, James, Kapenga, LeMahieu, Marklein, Nass, Quinn, Tomczyk, and Wanggaard; (2) intervenor-respondent the Wisconsin Legislature; and (3) intervenors-respondents Johnson, et al. On January 22, the same parties moved for reconsideration of that January 11, 2024 Order. On January 24, this Court ordered all parties not moving for reconsideration to file a response no later than January 26, 4:00 p.m.

The Commission Respondents in this matter—the Wisconsin Elections Commission; Don Millis, Robert F. Spindell, Jr., Mark L. Thomsen, Ann S. Jacobs, Marge Bostelmann, Carrie Riepl, in their official capacities as members of the Commission; and Meagan Wolfe, in her official capacity as administrator of the Commission—did not file a merits brief in this original action, did not submit a substantive response to the first motion for reconsideration, and therefore do not submit a substantive response to this second motion for reconsideration.
