## STATEMENT OF THE CASE

This case involves a petition filed by the Kenosha County Division of Children and Family Services to terminate the parental rights of JMC to his biological child J.A.C. The petition alleged “abandonment,” “continuing need of protection or services,” and “failure to assume parental responsibility” under Wis. Stat. §48.415(1)(a)2, §48.415(1)(a)3, §48.415(2), §48.415(6). 7:9-12.

On the day of the fact-finding hearing, JMC entered a plea of no contest to “abandonment” under §48.415(1)(a)2. 64:31.

The case proceeded to disposition, and after receiving evidence and hearing argument, the circuit court ordered the termination of JMC’s parental rights. 78:17. As required by statute, the circuit court subsequently entered a written judgment and order terminating parental rights. 50:1-3. JMC filed a notice of intent to pursue postdisposition relief, pursuant to which the State Public Defender appointed the undersigned counsel. By and through counsel, JMC filed a notice of appeal. 67:1-2. On remand, JMC filed a motion for postdispositional

relief. 77:1-3. After hearing, the circuit court denied the motion.  
83:10. After considering briefs filed by all parties, this court  
affirmed. These proceedings follow.
