TREVOR MALONEY, being duly sworn, on oath deposes and says:

1. I am the Political Director of Dean 24, the official presidential campaign of Congressman Dean Phillips (the “Campaign”).

2. Except where expressly indicated, I subscribe this affidavit based on my personal knowledge. I am willing to testify regarding the facts set forth herein, upon due notice, if called to do so.

3. On January 2, 2024, at approximately 10 a.m., I attended an open meeting (the “Meeting”) of Wisconsin’s 2024 Presidential Preference Selection Committee (the “Committee”), as an observer on behalf of the Campaign.

4. A true and correct copy of the published agenda for the Meeting is attached hereto as Exhibit 1.

5. I attended the Meeting remotely using the Zoom webinar link listed on the Meeting agenda. I was able to hear and see the Meeting, but could not speak or participate.

6. The Meeting was called to order by Robert Kehoe, who announced himself as the Deputy Administrator of the Wisconsin Election Commission (“WEC”).

7. Mr. Kehoe introduced his WEC colleague Riley Willman as the acting secretary responsible for taking minutes of the Meeting.

8. Following a motion and vote, the Committee selected Robert Lang as the Committee’s chair. Mr. Lang thereafter presided over the remainder of the meeting.

9. Mr. Lang asked the chairs of each of the major political parties to announce their respective parties' list of presidential primary candidates.

10. Brian Schimming, chair of the Wisconsin Republican Party, read his party's list first, naming six candidates.

11. Ben Wikler, chair of the Wisconsin Democratic Party, read his party's list next, naming only one candidate: President Joe Biden.

12. Mr. Lang inquired whether any member of the Committee had any changes or objections to the lists announced by the parties, but no member of the Committee voiced any changes or objections.

13. Upon motion, the Committee voted unanimously to accept both parties' list without debate or discussion.

14. The Meeting concluded shortly afterward and lasted roughly five minutes in total.

15. I am aware that the Meeting was video recorded by WisconsinEye, an independent news organization that records State Capitol proceedings for broadcast to the general public.

16. WisconsinEye has made its video recording of the Meeting publicly available on its website, at <https://wiseye.org/2024/01/02/2024-presidential-preference-selection-committee/> (last visited January 20, 2024).<sup>1</sup>

17. The video recording available on the WisconsinEye website, despite some intermittent audio distortion, appears to be an accurate recording of the Meeting that I attended.
