AFFIDAVIT OF (ANAIS L.)

I, being duly signed and sworn, states as follows:

- 1. I am an adult resident of the State of Wisconsin.
- 2. To protect my privacy, I am proceeding in this matter under the pseudonym "Anais L."
- 3. I believe that I have the right and should have the legal authority to make decisions about whether or not to have a child, including the right to make decisions about whether or not I will carry a pregnancy to term.
- 4. I am a female of child-bearing years. Although I have been diagnosed with polycystic ovary syndrome, this medical condition does not prevent me from becoming pregnant.

- 5. I received an abortion for an unintended pregnancy in 2016.
- 6. At the time I became pregnant, I did not believe that I could become pregnant without the assistance of fertility treatment because I of the polycystic ovary syndrome diagnosis.
- 7. I became pregnant with my then-boyfriend. I did not wish to have children with him, and he did not wish to have children with me. My boyfriend immediately suggested I obtain an abortion. I understood that to mean he would not be a supportive father to the child.
- 8. At the time I became pregnant, I was studying at a local technical college to become a substance abuse counselor and working a low wage, part-time job as a restaurant server. I was struggling to support myself financially.
- 9. I knew my studies in substance abuse counseling would require a Bachelor's degree, and I intended to transfer to a four-year university upon completion of my Associate's degree. I understood that my university coursework would be difficult, time-intensive, and expensive.
- 10. Ultimately, I decided to obtain an abortion because my boyfriend was unsupportive of the pregnancy, and I did not believe I could complete my education, begin my intended career path, and financially support myself and a child if I were to continue the pregnancy.
- 11. I have no doubt that obtaining an abortion was the right decision for me.

- 12. Following my abortion, I did complete my Bachelor's degree and I now work full-time in a professional position. I am still confident that I could not have completed my education and undertaken my career if I had had a child.
- 13. I have had no children since, and I do not wish to have children. I take affirmative measures to prevent pregnancy.
- 14. If I were to become pregnant again unintentionally in the future, I would consider obtaining an abortion.
- 15. I provide this affidavit in support of the Petition to the Wisconsin Supreme Court to Take Jurisdiction of an Original Action filed by Planned Parenthood of Wisconsin, et al.
