- I, being duly signed and sworn, states as follows:
 - 1. I am an adult resident of the State of Wisconsin.
 - 2. To protect my privacy, I am proceeding in this matter under the pseudonym "Jennifer S."
 - 3. I believe that I have the right and should have the legal authority to make decisions about whether or not to have a child, including the right to make decisions about whether or not I will carry a pregnancy to term.
 - 4. I am a female of child-bearing years. I have no medical condition that would prevent me from becoming pregnant.
 - 5. I received an abortion for an unintended pregnancy in 2008.

6. At the time I became pregnant, I was working as a full-time registered nurse (R.N.) in an intensive care unit. I had also applied to a Master of Science degree program to become a family practice nurse practitioner, and I was awaiting my acceptance results.

- 7. I became pregnant with my then-boyfriend shortly before our relationship ended. I did not wish to have children with him.
- 8. Around the time I learned I was pregnant, I also learned that I had been accepted into my graduate program to become a nurse practitioner. I planned to continue working full-time as an R.N. while attending the graduate program in order to finance my tuition, which would total approximately \$40,000.
- 9. Ultimately, I decided to obtain an abortion because I knew I would not be able to complete my education to become a nurse practitioner if I were to have a child, and because I did not wish to have children with a man whom was no longer in a loving relationship with me.
- 10. I believe that obtaining an abortion was the right decision for me.
- 11. Following my abortion, I did complete my Master of Science while continuing to work full-time as an R.N. However, the clinical hour requirements for the program were so great that I did have to reduce my

R.N. work to part-time during my final semester. I am confident that I could not have completed this advanced degree if I had had a child.

12. I am now a nurse practitioner



- 13. I have since married. My husband and I have had no children together, and we do not wish to. My husband has several children from a previous marriage, whom I have helped to raise and support. I take affirmative measures to avoid pregnancy.
- 14. If I were to become pregnant again unintentionally in the future, I would consider obtaining an abortion.
- 15. I provide this affidavit in support of the Petition to the Wisconsin Supreme
