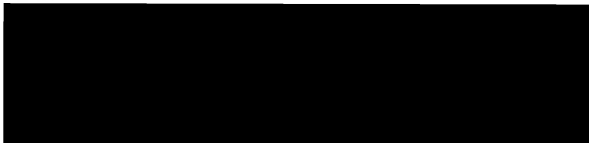
**AFFIDAVIT OF [REDACTED] (LESLIE K.)**

I, [REDACTED], being duly signed and sworn, state as follows:

1. I am an adult resident of the State of Wisconsin.
2. To protect my identity, I am proceeding in this matter under the pseudonym "Leslie K."
3. I believe that I have the right and should have the legal authority to make decisions about whether or not to have a child, including the right to make decisions about whether or not I will carry a pregnancy to term.
4. I am a female of child-bearing years. I have no medical condition that would prevent me from becoming pregnant.
5. I obtained an abortion for an unintended pregnancy in 2016.

6. At the time I became pregnant, I was taking affirmative measures to avoid pregnancy. My contraceptive intrauterine device (IUD) failed, resulting in the unintended pregnancy.
7. My fiancé and I did not wish to have children at the time I became pregnant. I was working extremely long hours in the field of healthcare information technology, and I traveled around the country on a weekly basis. I knew I would not be able to continue in my position if I were to have a child.
8. Ultimately, I decided to have an abortion because my fiancé and I did not wish to have the child, and I knew I could not advance in my career at the time with a child.
9. I firmly believe that obtaining an abortion was the right decision for me.
10. My now-husband and I have since had no children, and still do not wish to have any. I take affirmative measures to prevent pregnancy.
11. If I were to become pregnant again unintentionally in the future, I would consider obtaining an abortion.
12. I provide this affidavit in support of the Petition to the Wisconsin Supreme Court to Take Jurisdiction of an Original Action filed by Planned Parenthood of Wisconsin, et al.
