- I, being duly signed and sworn, states as follows:
 - 1. I am an adult resident of the State of Wisconsin.
 - 2. To protect my privacy, I am proceeding in this matter under the pseudonym "Maria L."
 - 3. I believe that I have the right and should have the legal authority to make decisions about whether or not to have a child, including the right to make decisions about whether or not I will carry a pregnancy to term.
 - 4. I am a female of child-bearing years. I have no medical condition that would prevent me from becoming pregnant.
 - 5. I received an abortion for an unintended pregnancy in 2014.

6. At the time I became pregnant, I already had a three year-old son. I was working two part-time jobs with unpredictable hours to support him, and trying to save approximately \$17,000 to attend cosmetology school. I dreamed of owning my own business.

- 7. I was not in a long-term relationship when I became pregnant. I did not wish to have children with my partner. He was not supportive of my pregnancy and had a previous child of his own whom he struggled to support financially. I knew I would be a single mother for the child if I were to continue the pregnancy.
- 8. I also knew I could not support my existing son and another child on my already limited income, and that I would not be able to save enough money for school with two children.
- 9. Ultimately, I decided to obtain an abortion because I did not wish to have a child with the unsupportive partner, I knew I could not financially support the child, and I knew I would not be able to achieve my dream to graduate from cosmetology school and own my own business if I were to have the child.
- 10. There is no doubt in my mind that obtaining an abortion was the right decision for me.

- 11. Following my abortion, I did attend and graduate from cosmetology school and opened a salon, while also supporting my now-13 year old son. I am confident that I could not have achieved this success if I had had a second child.
- 12. I have since married, and my husband and I are both small business owners. We have raised my son together, and have had no further children. We do not wish to. I take affirmative measures to prevent pregnancy.
- 13. If I were to become pregnant again unintentionally in the future, I would consider obtaining an abortion.
- 14. I provide this affidavit in support of the Petition to the Wisconsin Supreme Court to Take Jurisdiction of an Original Action filed by Planned Parenthood of Wisconsin, et al.
