**RESPONDENTS' MOTION  
TO RESET BRIEFING SCHEDULE**

1. On June 17, 2024, the Court entered an order in this case setting the following briefing schedule: (1) Petitioners' opening brief due July 17, 2024; (2) Respondents' brief due August 6, 2024 (assuming Petitioners file on July 17); and (3) Petitioners' reply brief due August 20, 2024 (assuming Respondents file on August 6).

2. For the reasons described below, Respondents respectfully request the Court reset the briefing schedule to the following: (1) Petitioners' opening brief due July 24, 2024;

- (2) Respondents' response brief due September 3, 2024; and
- (3) Petitioners' reply brief due September 17, 2024.

3. During the original time set for Respondents' brief, Respondents' lead counsel has pre-planned vacations scheduled for July 25–29 and August 3–11.

4. Respondents' lead counsel also has primary responsibility for drafting several other significant briefs during late July and August:

- An appellate response brief due August 14, 2024, in *Sidney v. WEC*, No. 24AP190 (Wis. Ct. App.);
- An appellate reply brief due September 3, 2024, in *StubHub Inc. v. DOR*, No. 24AP455 (Wis. Ct. App.).

5. Respondents have not requested any prior extensions in this matter.

6. Petitioners' counsel has authorized Respondents to state that Petitioners do not oppose this motion.
