No. 2024AP1643-OA      Strange v. Wisconsin Elections Comm'n

On August 20, 2024, petitioner David Strange, individually and as Deputy Operations Director-Wisconsin for the Democratic National Committee, filed a petition for leave to commence an original action under Wis. Stat. § (Rule) 809.70, with a supporting memorandum and a supporting affidavit.

On August 23, 2024, in response to this court's August 22, 2024 order, the named respondents in this matter, the Green Party of Wisconsin and the Wisconsin Elections Commission, its members, and its administrator, filed responses to the petition for original action.

Also on August 23, 2024, the Republican Party of Wisconsin filed a motion to intervene, as well as an alternative motion for leave to file a non-party brief amicus curiae. Pursuant to this court's order, on August 26, 2024, all of the parties to this action filed responses to the motion.<sup>1</sup>

Additional motions for leave to file non-party briefs amicus curiae were filed on August 23, 2024, by Governor Tony Evers and by Rita Maniotis and Travis Kobs.

On August 26, 2024, the Green Party of Wisconsin filed a motion to dismiss the original action petition, as well as a memorandum in support of the motion.

Also on August 26, 2024, Rita Maniotis and Travis Kobs filed a motion to intervene and a supporting memorandum.

The court has considered the filings in this case. Accordingly,

IT IS ORDERED that the petition for leave to commence an original action is denied. We determine that the petitioner is not entitled to the relief he seeks; and,

IT IS FURTHER ORDERED that all other pending motions are denied as moot.
