**MOTION FOR ADMISSION *PRO HAC VICE* OF  
NONRESIDENT ATTORNEY ANNABELLE E. HARLESS**

Amici Curiae, Black Leaders Organizing for Communities (“BLOC”), Voces de la Frontera (“Voces”), League of Women Voters of Wisconsin (“LWVWI”), Cindy Fallona, Lauren Stephenson, and Rebecca Alwin (collectively, “Amici Curiae”), by their attorneys, Stafford Rosenbaum LLP, move the Court for an order pursuant to SCR 10.03(4) allowing nonresident attorney Annabelle E. Harless, of the Campaign Legal Center, 55 W. Monroe St., Ste. 1925, Chicago, Illinois, permission to appear and participate in this action as counsel for Amici Curiae. This motion is supported by the contemporaneously filed Affidavits of Douglas M. Poland and Annabelle E. Harless. In further support of this motion, Amici Curiae state as follows:
